Position Overview:

The asphalt terminal operator is responsible for performing duties related to the liquid asphalt terminal operation, and the safe and responsible operation of all applicable machinery and equipment.

Essential Functions:

The following list is intended to be exemplary of the functions and physical demands of the position however it is not exhaustive of all day-to-day activities. The incumbent will be required to perform any or all of the following in a given day or week:

- While performing the duties of this position the incumbent is regularly required to stand for up to 10-12 hours (rest breaks as required by law will be provided), use hand, handle or feel, reach with hands and arms, talk or hear, walk, climb stairs, ladders, & catwalks, climb to elevated catwalks (+40 feet), stoop, bend, twist, kneel and crouch;
- Must be able to consistently lift and/or manipulate with push/pull force +/- 50 pounds;
- Responsible for facilitating the offloading of liquid asphalt from rail cars to above ground tanks which includes but is not limited to: climbing to the top of rail cars, opening tank hatches, operating six inch manual gate valves, connect steam and product lines to rail cars; Processing multiple components via automated Asphalt Modifying equipment which includes but is not limited to follow precise guidelines and procedures to modify Asphalt Feed stocks into Performance Graded finished products that must meet Multiple State DOT Agency specifications consistently.
- Follow and stay up-to-date with all Standard Operating Procedures, Process Control Guidelines, Safe Work Practices; comply with all applicable Environmental, Health & Safety regulations and directives.
- Flexibility with regard to schedule working extended hours, nights, weekends, and holidays when business needs dictate.

Work Conditions:

Incumbent must be able to tolerate moderate to loud noise level (PPE will be provided, including hearing protection as required), long hours standing, walking, and laboring outdoors in varying weather conditions – frequently in extreme heat, the most demanding time of the season.

Other Accountabilities/Responsibilities:

Performs related and unrelated duties as may be required.

Position Requirements:

High school diploma or equivalent. Reliable, responsible, honest, organized and able to use good judgment, possess basic math skills and superior communication skills. 2-3 years prior industrial/manufacturing work environment preferred. Industry related experience a plus.
